<u>M12</u> Motion made by Trustee Ezra Geist, seconded by Trustee Ryan Beers, to approve the minutes of the July 18, 2023 Regular Board Meeting as presented. Roll call. All ayes. Motion carried.

REPORTS:

DPW-Logan Sliter -

Logan said that he would take the new truck to be outfitted by the end of August and it probably will take two to three weeks or more before we get it back again.

Trustee Amidon asked about the water, Logan reply that everything is good at this time.

<u>Code Enforcement Officer</u>- Bill Rusby – No permits were issued for the month of July.

Bill reported that Julio's Scrap and Hauling Service on 30 Hurlbut Street needs to be free of vehicles, metal, appliances and junk. Julio reported to Bill that the inside of the building has a lot of antiques. Mayor Prete said that they would have to check on the Zoning Board on the classification of a junk yard in the Village. Bill said that he did make an attempt to clean the area up but has moved more back in the same spots. Bill said that he may be too close to the railroad tracks and it is not a good situation, you can't get into the building if there was ever a fire.

Patty Lupo, Treasurer asked Bill when he was going to start working on the fire inspections. Bill replied that he needs to start soon.

<u>Treasurer</u> – Patricia Lupo – Profit and loss reports for July 2023. General Fund income was \$109,346.82 and expenses were \$33,936.77. Water Fund income was \$1,087.04 and expenses were \$6,092.30.

Shaun said that a radar trailer was placed facing west toward Canaseraga, nearby his residents on July 1^{st thru}7th. Shaun sent a F.O.I. L. to the Sheriff's Office, requesting information on the results from the radar study. The average speed of the vehicles was 57 mph in a 30-mph speed zone. Mayor Prete said he would write another letter to Sheriff's Dept. asking for more traffic control in this area. Trustee Geist asked if we could put a warning in the Village Newsletter.

<u>Old Business & Tabled Items:</u> Mayor Prete said that he has been working on updating the Employee Handbook/ Policies and Procedures. The mayor read all the new changes to the Board Members to be approved. Discussion followed.
