#### REPORTS:

<u>Cemetery</u> – Tom Hunt – Tom reported to the Board Members that he received a notice from Snyder Brothers that effective April 1, 2024 the cost for grave openings and closing will now be \$425.00. There will also be an additional charge of \$300.00 for Sundays and Holidays, and \$250.00 for Saturdays and an overtime charge of \$150.00 per hour for funerals that arrive at the cemetery after 3:30 pm.

Tom strongly recommends that we approve the increases in the cemetery fees and the funeral homes will have to pass the increase onto the families.

Trustee Amidon wasn't comfortable with the proposed fee increases. Trustee Amidon will investigate if there are other companies that provide cemetery services and if they use a mini track back hoe.

Small discussion followed and it was agreed that the trustee would post pone the vote until the next regular meeting in March.

<u>Code Enforcement Officer</u> - Bill Rusby – No building permits for January. Code School March 11-13, 2024, fee for school and milage and cost of certificate split with North Hornell. Annual Report has been submitted.

Spoke with Wendy Recktenwald about plans for an Ice Cream stand, gave her recommendations, steps to follow, etc. She's going to look into it and will get back to us.
