DPW/Water Department: Joe Demick – Absent

Written DPW report: Cold patching of potholes has begun and will continue as needed. Took delivery on new Ferris zero turn and the utility trailer. Backhoe and cemetery mower have been serviced.

Request to post old crack seal kettle cart for sale on Auctions International, along with some older pumps that are taking up space in the shop we have since upgraded. Working on rough estimates for pickleball court and basketball resurface/ new hoops. Need all details as far as fencing around courts, lighting, seating and etc. This will give us our most accurate idea for pricing. Working on removing leaves from park after complaint, leaf collection box is in disrepair so a new one needs to be built this spring. Comment was made by Trustee Amidon that the leaves need to be picked up in the park.

Water report: No notable changes in water plant, will be ordering chlorine the end of the month. Will begin restoration to a few spots that need top soil. Per Chris Schmidt, from Badger Meter, we should wait to swap meters until after the next meter reading is done to ensure snow cover did not affect the reading capabilities.

Treasurer Lupo comment that a lot of our meters are starting to fail.

<u>Treasurer</u>: Patricia Lupo – Profit and loss reports for February 2025. General Fund income was \$2,621.68 and expenses were \$21,690.05. Water Fund income was \$51,267.39 and expenses were \$50,035.49.

The franchise shall be for term of 10 years. The annual franchise fee will be 5% of the annual Gross Revenue.
